1. The **Shortlist** for applicants who applied under Clusters **4 and 5, (Part of Elgon and Karamoja)** who will be subjected to **Aptitude Tests** is now out, and available on the ESC Website [www.esc.go.ug](http://www.esc.go.ug)
2. All applicants under Clusters **4 and 5, (Part of Elgon and Karamoja)** will do the **Aptitude Test** from **Monday**

**the 5<sup>th</sup> May to Saturday the 10<sup>th</sup> and Monday the 12<sup>th</sup> May 2025 starting at 8:00 am.** The Aptitude schedules showing UGIFT schools, names of applicants and Centre/venue for the test are attached.

3. The list for successful applicants who will be **shortlisted** for **oral interviews** will be out on the ESC Website [www.esc.go.ug](http://www.esc.go.ug) **as soon as possible.**  
It will also include names of **applicants directly shortlisted for oral interviews** for different subjects in different schools **under Clusters 4 and 5 (Part of Elgon and Karamoja)** whose ratios did not require Aptitude Testing.
4. All Shortlisted applicants **MUST** appear for the Aptitude Tests as scheduled and **MUST** come along with National Identity Cards.

1. The dates for conducting Aptitude Tests for the remaining Clusters will be communicated at an appropriate time.
2. Those whose names do not appear on the shortlist under **Cluster 4 and 5 (Part of Elgon and Karamoja)** should consider themselves unsuccessful.


